Sickness absence within the police force

The overall objective of this study is to achieve general knowledge about sickness absence within the police force and more specifically about gender differences. Sickness absence is more frequent among women than men within the Police. Increased knowledge in this area will make it easier to prioritize and take action to decrease sickness absence for women in the police organization. In the long run the aim for the police organization is to have an organization without differences in health and sickness absence between men and women. More scientific knowledge is needed about factors of importance for sickness absence to reach that goal. Data on sickness absence and work conditions from questionnaires distributed to all employed within the Police in 2005, 2007, and 2009 are being analyzed.

One sub-study also focus on short- and long-term sickness absence 2007 among women and men in the Stockholm Police county (Polismyndigheten i Stockholms län). Both survey and sick-leave register data are analyzed.

Special focus is gender differences in sickness absence, the associations between threats, violence and threats of violence, harassments, leadership, and sickness absence as well as sickness presence.
